**Terms and Condition of Sale**

1. We accept cash, checks with proper ID, Visa, MasterCard. Unknown buyers to the Company may be asked to secure a check purchase with a Visa/MasterCard. 13% Buyer's Premium on all purchases, 3% discount on cash and check purchases, 6% sales tax. Tax exemption numbers must be on file with the Company or tax will be charged with no exception.
2. The Company reserves the right to withdraw any item at any time and to change the make up of any lot offered before it is sold.
3. While the Company has endeavored to catalogue and describe the property correctly, all property is sold "as is" and neither the Company nor its consignors will be responsible for the description, genuineness, provenance, condition, fitness or merchantability of the property. No statement contained in the catalogue, advertising or made orally at the sale or otherwise shall be deemed to such a warranty or representation or an assumption of liability.
4. The highest bidder acknowledged by the auctioneer shall be the purchaser. At that moment, title passes to the designated bidder, thereupon assuming full risk and responsibility for said item. In the event of any dispute between bidders, the auctioneer shall have absolute discretion to determine the successful bidder, in which event this determination shall be final, or to re-offer and re-sell the article in dispute.
5. If the auctioneer, in his sole and final discretion, decides that any original bid is not commensurate with the value of the article offered, or having acknowledged an original bid, that any advance thereafter is not of sufficient amount, he may reject the same.
6. If any dispute arises after the sale, the Company sale record shall be conclusive as to who was the purchaser, the amount of the highest bid, and all other respects.
7. While many items in the auction will be sold without reserve, the auctioneer withholds the right to bid on behalf of each consignor for the purpose of protecting reserves; that is, placing bids during the auction, if any, when the highest outstanding bid is less than the reserve on the lot being offered.
8. No properties purchased during the auction may be removed prior to payment in full.
9. All absentee and phone bidders must phone 724-222-8020 to make bid arrangements with The Three Rives Auction Company prior to their bids being accepted and executed. Email bids through the website will not be accepted with out direct phone contact. All phone bids and internet bids are subject to an 18% buyer's premium and the buyer is responsible for shipping and packing charges. Absentee, phone and internet bids must be made using Visa/MasterCard.
10. The auctioneer or representative of the Company may act on behalf of absentee bidders; that is, bids left on particular items by non-attendees who wish to participate as bidders/buyers in the auction.
11. The Three Rives Auction Company reserves the right to ask any person or group of people to leave the auction if in the opinion of the auction staff the individual or group is acting in any manner that the company deems is detrimental to the auction company or its consignors.
12. All packing and shipping costs are the responsibility of the buyer. These services will be provided by Mail, Boxes and More. All fees for these services will be billed on the credit card authorized for purchases. All items will be insured for the purchase price. All invoices are automatically packed and shipped. We strive to have your items shipped within 10 business days of the auction. Sometimes that time will need to be extended due to the high volume in internet purchases.
13. Guns that require an FFL fee and are to be shipped to the Buyer arrangements will have to be made for shipping from our FF license holder to a FF license holder chosen by the Buyer.
14. Guns will be shipped by ARH Sports Shop for \$35 packing fee per gun, plus shipping which will be charged to your credit card.
15. Large item pick-up is the first Monday after the auction form 10am to 6pm.
16. Any item not picked-up after the first Monday after the auction will incur a \$10.00 storage fee per lot per day.
17. The Three Rivers Auction Company is not responsible for any damage for any item left after the first Monday after an auction.
18. If an item(s) is not pick-up within 21 days The Three Rivers Auction Company will sell the item(s) at auction.
