1. All bidders agree to leave a minimum \$20.00 opening bid.
2. The Three Rivers Auction Company is hereby authorized to bid on the following lots up to the price stated, not including Buyer's Premium, tax or shipping. The Three Rivers Auction Company will bid competitively (as though I were present, bidding on my own behalf) to obtain the item(s).
3. The Three Rivers Auction Company assumes no responsibility for failure to execute these bids for any reason whatsoever.
4. I understand that if my bid is successful, the total purchase price will be the aggregate of the final bid and a Buyer's Premium of 13%, together with any sales tax due and any shipping and handling costs.
5. The bidder shall be notified by telephone if he or she is the successful bidder to make arrangements for immediate payment and removal. All items will be shipped by an independent shipping contractor. Buyer's credit card will be billed by shipper for all shipping services.
6. In the event identical bids are submitted, the earliest bid determined by the date on this form will take precedence.
7. All tie bids go to the bidder present at the auction house.
8. All bids shall be treated as offers made subject to the Conditions of Sale.
9. Unlimited bids or instructions to bid an item to buy at any price will not be accepted.
10. These bids will not be executed unless a CREDIT CARD NUMBER HAS BEEN LEFT AND PAYMENT ARRANGEMENTS HAVE BEEN MADE IN ADVANCE.
