

**THE THREE RIVERS AUCTION COMPANY**

**SUPPLEMENTAL TERMS AND CONDITION FOR SALE OF VEHICLES ON-SITE**

By bidding on the vehicle offered at the auction today, I agree to be bound by and to comply with the following terms and conditions:

1. All sales of vehicles are "AS-IS" based solely on the inspection of the bidder. While The Three Rivers Auction Company (the "Auction Company") has endeavored to describe the property correctly, neither the Auction Company nor its consignors will be responsible for the description, genuineness, provenance, condition, fitness or merchantability of the property. No advertising or statement made orally at the sale or otherwise, shall be deemed to be a representation or warranty or an assumption of liability by the Auction Company.

2. The successful bidder understands that a 13% Buyer's Premium is applied to the sale of this vehicle and a discount of 3% is available for cash or **certified** check payment. The successful bidder must pay a **nonrefundable** deposit in cash, by cashier's check or approved Visa or MasterCard of \$2000.00 at the time of sale. In the event the successful bidder fails to pay the balance of the purchase price in immediately available funds within 72 hours, the Auction Company shall retain the nonrefundable deposit as liquidated damages, and may, at the option of the consignor, re-offer the vehicle for sale.

3. The successful bidder will not be permitted to take delivery of the vehicle and the title until it has paid the total purchase price in full, in immediately available funds. Balance due, if any, before the title transfer must be in cash or certified check. The successful bidder may only take possession of the vehicle on the day of sale if the purchase price is paid in full in cash or by approved Visa or MasterCard and **show proof of insurance**.

5. Title information will be completed once the vehicle is paid in full, after which time the representatives of the vehicle will sign and notarize the title. When the title is completed The Three Rivers Auction Company will mail the title to the Buyer by registered mail.

6. If the vehicle must be held until the funds clear, it will be stored at the Auction Company, unless other arrangements have been made, at the successful bidder's risk of loss; provided, however if the Auction Company is required to store the vehicle after 72 hours from the time of the Auction, the Buyer will be required to pay the Auction Company the sum of \$100 per day for such storage services. Furthermore, if the successful bidder fails to take delivery of the vehicle after notification by the Auction Company that the funds have cleared, the Auction Company may dispose of the vehicle in its sole discretion, and neither the Auction Company nor the consignor shall have any liability therefore.

7. The successful bidder will receive, at time of final payment of the total purchase price in full, an open title. It is the responsibility of the successful bidder, to complete the title transfer, pay all applicable taxes, obtain license plates, complete the registration process, obtain insurance and comply with laws at the sole expense of the successful bidder, and neither the Auction Company nor the consignor shall have any liability therefore.

8. All bidders must be 18 years of age and have a valid driver's license.

9. The sale of the vehicles is subject to confirmation by the consignor or its representative.

10. By bidding on the vehicles and signing this document, I voluntarily waive any right to stop payment on check or credit card for any reason, and I understand that all vehicles are sold "AS-IS" without recourse.
